*Reference:* IIW Constitution 2006 and IWNZ Bylaws 2007 page, 4 E a)

“If an active member resides in an area of a country where there is no Inner Wheel Club, the National Governing Body of that country can grant her Membership At Large status. Application must be made to that National Governing Body through her former Club or District where there is no former Club through disbandment. Payment of International Inner Wheel capitation fees must be made to that Governing Body. Such a member cannot vote or hold office.”
